

APPLICATION FOR SELECTION FOR A POSITION ON THE BOARD OF DIRECTORS

Dear Applicant,

There are two openings on the Board of Directors for Director, **Position Number Three and Position Number Five**. Each Position is an at-large position within the District. Selection to the Board will be by vote of the current Board Members. **Position Number Three** is for the balance of term which expires on June 30, 2025. **Position Number Five** is for the balance of the term which expires on June 30, 2027. This position is a public office, and the candidate must be qualified to serve in public office during the term. **Position Number Three** will be up for election at the May 2025 Election. **Position Number Five** will be up for election at the May 2027 Election

Completed Applications must be received by Monday, May 13, 2024 at 2:00 p.m. Applications are to be delivered to the District Office in the La Pine Community Center located at 16405 1st Street, La Pine, Oregon. Completed applications can also be mailed to LPRD, P.O. Box 664, La Pine, OR 97739. The District office has shortened hours at the present time, but hours are posted on the front door.

The Board has selected a candidate interview date of Thursday May 16, 2024 at 3:00 p.m. at the Community Center. Interviews will be conducted at the end of that business meeting.

The District is approximately 85 square miles. It runs from Fall River on the North to the Klamath County Line on the South, and from the National forest boundary on the east and on the west. Board Members are required to reside within the District's boundaries during their term of office. By signing this application, you are representing that you reside within the District.

The Board is anxious to fill this Board Position with a qualified applicant who can demonstrate a serious commitment to the citizens of the District in performing the duties required of a member of the Board of Directors. The position is a public office, and the Board is responsible to the citizens of the District to be accountable, transparent and responsive to the needs of its citizens. The rules governing the actions of the Board of Directors are set forth on the Oregon Revised Statutes, various State Administrative Regulations and on the policies adopted by the District's Board of Directors. The primary duties are to plan and oversee the District's budget and to set policies for the proper running of the District's business, programs, and future needs.

We are requesting the responses to the attached questions be typed.

Please answer each question fully. Use **separate paper** to answer the questions and note the number of the question that your answer applies to. More than one answer can be on such sheet. There is no word limitation for your answer. Attach your answers to the Verification page and the Questions page.
